

#### **ORDINANCE NO. 144**

#### CITY OF THE VILLAGE OF CLARKSTON

# AN ORDINANCE TO ADOPT BY REFERENCE THE OAKLAND COUNTY WATER RESOURCES COMMISSIONER ENGINEERING DESIGN STANDARDS FOR STORM WATER FACILITIES.

### THE CITY OF THE VILLAGE OF CLARKSTON ORDAINS:

#### SECTION 1.01

The City of the Village of Clarkston shall adopt by reference the Oakland County Water Resources Commissioner Engineering Design Standards for Storm Water Facilities providing requirements, rules, and design criteria for storm water management as adopted by the Water Resources Commissioner on January 1, 2006, and as revised on April 24, 2012 as amended from time to time.

#### SECTION 2.01 — Repealer.

All other ordinances and/or resolutions inconsistent with the provisions of this Ordinance are, to the extent of inconsistency, hereby repealed.

SECTION 3.01 - Severability.

Should any section, subdivision, clause, or phrase of this Ordinance be declared by the courts to be invalid, the validity of this Ordinance as a whole, or in part, shall not be affected other than the part invalidated.

#### SECTION 4.01 — Violations.

A. Civil Infractions. A violation of this Ordinance is a municipal civil infraction, punishable by a civil fine of not more than \$500.00, plus any costs, damages, and expenses.

B. If stormwater management has not been adequately maintained, the City may notify the Applicant(s) in writing and require tire necessary maintenance or repairs within 90 days of the written notice. Should the Applicant fail to comply with the provisions of this Ordinance, the City may, after giving reasonable notice and opportunity for compliance, have the necessary work done and the Applicant shall be obligated to promptly reimburse the City for all such costs incurred. If said costs are not paid by the Applicant, the City may pursue the collection of same through appropriate court actions of as lien on the property.

C. When emergency measures are necessary to mediate a nuisance, to protect public safety, health, welfare, or to prevent loss of life, injury or damage to property, the City is authorized to, but not required to, carry out or arrange for all such emergency measures. Property owners shall be responsible for the cost of such measures trade necessary as a violation of this Ordinance and shall promptly reimburse the City for all such costs. If said

costs are not paid by the Applicant, the City may pursue the collection of same through appropriate court actions or as lien on the property.

<u>SECTION 5.01</u> — Effective Date.

This Ordinance is hereby declared to have been adopted by the City Council of the City of the Village of Clarkston, at a meeting thereof duly called and held on the 9<sup>th</sup> day of October 2023, and shall be published in the manner prescribed by law and shall become effective 20 days after publication.

# **Resolution - Repaving of W. Washington Road**

WHEREAS, in the August 28, 2023 City Council Meeting, Council approved the repaving of Depot Road, piggybacking on an existing vetted contract the Road Commission of Oakland County has with Ace-Saginaw Paving Company, with an anticipated start date of October 21, 2023, and;

WHEREAS, upon learning of Council's approval to repave Depot Road, the Road Commission made the decision to also repave (at the RCOC's expense) two RCOC-maintained roadways in the City (S. Holcomb and White Lake Road) at the same time as the Depot Road paving, and;

WHEREAS, when the City inquired about the possibility of also repaving W. Washington Road (another RCOC-maintained roadway) at the same time, it was determined that this could be done if the City was open to using the Tri-Party Funding Program, and;

WHEREAS, the City re-joined the County's Tri-Party Funding Program in 2021, allowing the City to take advantage of 3-way funding (Oakland County, RCOC and the City) designed to improve RCOC-maintained roadways in the City, and;

WHEREAS, the RCOC has provided an estimate of \$42,642 to repave W. Washington Road, from Main Street to Holcomb Road at the same time as the Depot Road, S. Holcomb and White Lake Road paving, and;

WHEREAS, under the Tri-Party Funding Program, a combination of 2023 and 2024 funds would be utilized to cover the \$42,642 cost, with Oakland County, RCOC, and the City of the Village of Clarkston each paying \$14,214 (\$42,642 / 3 = \$14,214), and;

WHEREAS, if W. Washington is not repaved under the Tri-Party Program this year at the same time as the other roads, it will likely not be repaved for another 2-3 years and at a much higher cost, and;

WHEREAS, it is recommended that the City utilize the Tri-Party Funding Program to repave W. Washington as delineated in the attached Cost Participation Agreement, with the City's \$14,214 share of the cost coming from the City's Parking Fund, and;

**NOW THEREFORE, BE IT RESOLVED** that the City of the Village of Clarkston hereby authorizes the City Manager to contract with the Road Commission of Oakland County to repave W. Washington Road under the Tri-Party Funding Program, with the City's \$14,214 share paid from the City Parking Fund (231-000-001.000) designated for road, sidewalk and parking lot maintenance.

COST PARTICIPATION AGREEMENT CONSTRUCTION Washington Street Main Street to Holcomb Road City of the Village of Clarkston Board Project No. 57501

This Agreement, made and entered into this \_\_\_\_\_ day of \_\_\_\_\_, 2023, by and between the Board of County Road Commissioners of the County of Oakland, Michigan, hereinafter referred to as the BOARD, and the City of the Village of Clarkston, hereinafter referred to as the COMMUNITY, provides as follows:

WHEREAS, the BOARD and the COMMUNITY have programmed an asphalt overlay on Washington Street from Main Street to Holcomb Road, as described in Exhibit "A", attached hereto, and made a part hereof, which improvements involve roads under the jurisdiction of the BOARD and within the COMMUNITY, which improvements are hereinafter referred to as the PROJECT; and

WHEREAS, the estimated total cost of the PROJECT is \$42,642; and

WHEREAS, said PROJECT involves certain designated and approved Tri-Party Program funding in the amount of \$42,642, which amount shall be paid through equal contributions by the BOARD, the COMMUNITY, and the Oakland County Board of Commissioners, hereinafter referred to as the COUNTY; and

WHEREAS, the BOARD and the COMMUNITY have reached a mutual understanding regarding the cost sharing of the PROJECT and wish to commit that understanding to writing in this Agreement.

NOW, THEREFORE, in consideration of the mutual covenants set forth herein and in conformity with applicable law, it is hereby agreed between the COMMUNITY and the BOARD that:

- 1. The COMMUNITY approves of the PROJECT, declares its public necessity, and authorizes the BOARD to perform or cause to be performed, and complete the PROJECT along with all administration in reference thereto.
- 2. The PROJECT shall include total payments to the contractor. Any costs incurred by the BOARD prior to this agreement date shall be allowable.
- 3. The estimated total PROJECT cost of \$42,642 shall allocated in the following order:
  - a. Tri-Party Program funding in the amount of \$42,642.

The Tri- Party Program funds \$42,642 includes \$34,042 from 2023, and \$8,600 from 2024. If the 2024 funds are not available, this amount will be funded by the COMMUNITY.

- b. Any PROJECT costs above \$42,642 will be funded 100% by the BOARD.
  - 4. Upon execution, the BOARD shall submit and invoice to the COMMUNITY in the amount of \$11,347 (being 100% of the COMMUNITY'S fiscal year 2023 Tri-Party contribution).

Upon execution, the BOARD shall submit and invoice to the COUNTY in the amount of \$11,347 (being 100% of the COUNTY'S fiscal year 2023 Tri-Party contribution).

After February 1, 2024, the BOARD shall submit an invoice to the COMMUNITY in the amount of \$2,867 (being 100% of the COMMUNITY'S fiscal year 2024 Tri-Party contribution).

After February 1, 2024, the BOARD shall submit an invoice to the COUNTY in the amount of \$2,867 (being 100% of the COUNTY'S fiscal year 2024 Tri-Party contribution).

a. The invoice shall be sent to:

5. Upon receipt of said invoice(s), the COMMUNITY and the COUNTY shall pay to the BOARD the full amount thereof, within thirty (30) days of such receipt.


